Today, i.e. on 09.06.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E) of Telkalpara CCC & Jiaur Rahaman Mondal,AE(S&LP) .Sankar Chandra programme. at village Hutmura under Purulia(M) P.S. When our team at about 03.00 P.M. entered to the Domestic premises of Sk.Imran Ali, we found that he was enjoying electricity dishonestly by means of Meter bypassing by way of tampering service cable and run Domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses , service cable with bypass arrangement dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 03.30 P.M. after completion of inspection & necessary formalities.
