Respected Sir,

Today (24.06.17) I SI Asim Sengupta now posted at Purulia (M) P.S., Dist. Purulia beg to submit written complaint (type) against the driver of Truck Bearing No. WB55A-4396 to the effect that on 23.06.17 myself along with force were performing anti crime night mobile duty on Purulia- Chandankayary Pitch road by Govt. vehicle Reg. No WB/26C-5298. After that on the same day at about 22:25 hrs while we reached at Ghonga village and went to Pandey Akash Hotel for taking dinner, keeping vehicle beside the hotel.

Subsequently PD/301 Brahma Sankar Jha driver of the Govt. vehicle WB/26C-5298 was crossing the pitch road for urinal. At that time at about 22:45 hrs one Truck Reg. No WB55A/4396 was coming from Barameshia (Jkd.) side and proceeding towards Purulia with excessive speed and dashed our Police driver PD/301 Brahma Sankar Jha. As a result he fell down on the pitch road and received greivous bleeding injuries on his person. On seen the incident we rushed to the spot, the driver was fled away keeping the said involved truck Bearing Reg. No WB55A/4396 distance about 50 mtrs. from the P.O. I placed the vehicle guard as well as shifted the injured Police driver to Sadar Hospital Purulia for necessary treatment and admitted there after that doctor declared him death.

The incident was occurred due to rash and negligent driving of the driver.

So I pray that lawful action may kindly be taken against the driver of the truck bearing Reg. No. WB55A/4396.
