I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Muksed Ansary S/O Lt. Sanulla Ansary of Vill-Dakshin bahal PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 28.06.2017 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr.SAE(E) S/O Sri Murlidhar Bhattacharjee & Debdulal Banerjee, Sr. TSH, S/O Lt Shantilal Banerjee of Telkalpara CCC, WBSEDCL conducted a raid programme. at village Dakkshin bahal under Purulia(M) P.S. When our team at about 12.15 P.M entered to the Domestic premises of Muksed ansary, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and running domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses, at first disconnected the wire with hooking arrangement from LTOH line and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 12.30 P.M after completion of inspection & necessary formalities.

Muksed Ansary S/O Lt. Sanulla Ansary of Vill-Daksin bahal,PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
