In producing herewith one accd. Person namely (1) Bablu Acharjya (55) S/o- Lt Narayan Ch Acharjya, of Vill- Belguma Ps- Purulia (M) , Dist- Purulia With seized articles i) 40(fourty) sealed bottle of 80-up Country Spirit DILKHUSH each Bottle contains 600 ml ii) 8 (Eight) empty bottles of DILKHUSH country spirit iii) 06 pcs plastic glass iv) Cash of Rs 145/- as sales proceed which was seized under proper seizure list.

I beg to submit that today (02/07/17) during my mobile duty as per source information myself along with force held raid in a shop at Belguma Village under purulia(M) PS in between 17.45 hrs to 18.25. hrs and found two/three persons fled way from the said shop and apprehended one , on interrogation he disclosed his identity as Bablu Acharjya (55) S/o- Lt Narayan Ch Acharjya, of Vill- Belguma Ps- Purulia (M) , Dist- Purulia, owner of the shop and confessed his guilt for selling and keeping liquor . On demanding he failed to produced any licence/document .Hence I seized the above noted articles from his possession with proper seizure list duly signed by the witness and the accused person labeled the same and one bottle seized as sample. Arrested the accused person namely Bablu Acharjya (55) S/o- Lt Narayan Ch Acharjya, of Vill- Belguma Ps- Purulia (M) , Dist- Purulia after maintaining all rules of arrest. Issued memo of arrest .Informed him and his relatives regarding the ground of arrest.

Under the fact and circumstanced I therefore pray before your kind honour that lawful action may kindly be taken against 1) Bablu Acharjya (55) S/o- Lt Narayan Ch Acharjya, of Vill- Belguma Ps- Purulia (M) , Dist- Purulia.
