Today, i.e. on 05.07.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity,SAE(E), & Debdas Bhattacharjee, Sr.SAE(E) of Telkalpara CCC, WBSEDCL conducted a raid programme at village Dhuroi under Purulia(M) P.S. When our team at about 01.00 P.M. entered to the Domestic premises of Sidam Mahato, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.30 P.M.after completion of inspection & necessary formalities.
