I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Bijoy Dubey S/O Lt. Santosh Dubey of Vill - Arita, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 06.07.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity,SAE(E), & Debdas Bhattacharjee, Sr.SAE(E) of Telkalpara CCC, WBSEDCL conducted a raid programme at village Arita under Purulia(M) P.S. When our team at about 01.30 P.M. entered to the Commercial (Poultry Farm) premises of Bijoy Dubey, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run water pump motor set having capacity 300 watt, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.00 P.M.after completion of inspection & necessary formalities.

Bijoy Dubey S/O Lt. Santosh Dubey of Vill -Arita, PS-Purulia(M) has committed theft of electricity under section 135(1)(a). of the Electricity(Amendment) Act-2007.
