With due respect, this is to inform you that information received from reliable sources on 11.07.2017 about 9:30 am one Pangolin (Phataginus) was caught by the villager of Natua (GPS Location N-23°24'211", E-086°20'350") PO – Natua, GP – Ghonga, Block – Purulia-II, the staff of Purulia Para Range rushed there to rescue the Pangolin, but rescue the Pangolin with severe injury.

When it brought to Surulia Rescue Centre for treatment by veterinary surgeon but he declared that the animal already expired.

Necessary investigation regarding death of Pangolin will be done in due course.
