I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Noore Alam S/O Ejahar Alam of Vill -Hutmura, PS-Purulia(M) has committed theft of electricity under section 135 (1) (a) as detailed here under.

Today, i.e. on 17.04.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E) of Telkalpara CCC & Jiaur Rahaman Mondal, AE(S&LP) .Sankar Chandra Mahato, L.M., and Dayamay Mahato, TSH of Purulia Region ,WBSEDCL conducted a raid programme. at village Hutmura under Purulia(M) P.S. When our team at about 04.00 P.M. entered to the Domestic premises of Noore Alam, we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LTOH Line and run Domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses , Hooking wire dismantled and seized and seizure list prepared .The seized material labelled in presence of the local witnesses. The inspection team left the aforesaid location at about 04.30 P.M. after completion of inspection & necessary formalities.
