In producing herewith the accused persons namely (1) Sk. Jabir (29) s/o Sk. Mustakin r/o Hutmura Ps- Purulia(M), Dist Purulia & (2) Sk. Tufan (29) S/O Abdul ohab of Kantadih, P.S- Jhalda, Dist. Purulia under arrest and seized articles (i) One white coloured red lining printed bag styled as ANNAPURNA'S BREAK FAST MURI 200 loaded with 22.400 kg Cannabis/Ganja 2) 03 brown colour envelope containing 100 gm each of loose Cannabis/Ganja Which have been collected from bag as sample & 3) One Apache Black and white colour motorcycle bearing Reg. No JH/02AC-9646 shows on the number plate under proper seizure list sealed and level duly signed by the witnesses and accused persons, I SI Sadhan Kr. Banerjee, O/C Purulia (M) PS do hereby lodge this complaint suo-motu against the above noted 02 (two) accused persons for committing an offence punishable U/S 20 (b)(i)/29 NDPS Act 1985. Today (17.04.17) at 18:55 hrs. received a reliable source information that 02 (two) drug peddler namely (1) Sk. Jabir s/o Sk. Mustakin r/o Hutmura Ps- Purulia(M), Dist Purulia & (2) Sk. Tufan S/O Abdul Ohab of Kantadih, P.S- Jhalda, Dist. Purulia riding on a One Apache Black and white colour motorcycle bearing Reg. No JH/02AC-9646 are coming from Purulia Town area towards Jhalda.

The source also informed that they were carrying one plastic bag containing Cannabis/Ganja on the back side of motorcycle. I noted the fact in G.D. vide Purulia (M) PS GDE No 1152 dtd 17.04.17, informed the matter to CI Sadar, Purulia & Dy. SP (D&T), Purulia, and other Superiors Officers of Purulia District. As per their direction myself along with my source SI Lakshmi Kanta Pati, SI Gopal Man, C/665 Robindra Nath Gorai, C/1051 Satyajit Acharyya, C/1454 Ashok Kr. Mahato vide C.C. No. 1813 dtd 17.04.17 left for Sainik School side area to work out the information by Govt. vehicle having Reg. No. W.B 56B/5363 also carried seal, gala, match box, candle, brown paper, weighing instrument.

Today i.e, 17.04.17 at 19:25 hrs reached near Sainik School with in a visible distance of place of assembly of suspect & got down from the vehicle, kept the vehicle in a hiding place, we ambushed ourselves at different places with proper briefing. Kept watch at the pacca road approaching to the Sainik School. At about 20:05 hrs one motorcycle rider, identified as Sk Jabir with pillion rider duly identified by source as Sk Tufan with Apache Black and white colour motorcycle bearing Reg. No JH/02AC-9646 arrived at the pacca road just beside the Sainik School. We watched them for a considerable period, meanwhile,

I along with accompanied officers & force disclosing our identities surrounded them & also detained them with the said bag. On being asked they disclosed their identity as (1) Sk. Jabir s/o Sk. Mustakin r/o Hutmura PS- Purulia(M), Dist Purulia & (2) Sk. Tufan (29) S/O Abdul Ohab of Kantadih, P.S- Jhalda, Dist. Purulia. On interrogation they confesed that the said bag contained Cannabis/Ganja. They also stated that they carrying the same for selling at Jhalda side. Informed the matter to CI, Sadar, Purulia and Dy. SP (D&T) Purulia. Thereafter, I issued notice to both accused persons asking them whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, both detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate, accordingly informed to the Sri Dibya Jyoti Das, BDO Purulia-I(Exe. Magistrate) with a request for search and seizure as per provision of section 50 of NDPS Act. Meanwhile, we searched for public witnesses with the help of accompanied officer & force. After a while two public witnesses namely 1) Kripa Sindhu Mahato S/o Nityaranjan Mahato of Vill.- Chakra, PS - Purulia (M), Dist - Purulia, 2) Motilal Mahato S/o Rupchand Mahato of Manguria, PS- Purulia (M), Dist- Purulia became ready to assist us in conducting search & seizure. Within half an hour CI Sadar, Purulia and BDO Purulia-I arrived at the spot and disclosed their identity and explained the reason for arriving there. After their arrival I started search & seizure process at PO. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Dibya Jyoti Das, B.D.O Purulia-I and detained persons. At first myself with the help of officers and force searched Sk Jabir and Sk Tuffan and their belonging at the spot. During search of them found one white coloured red lining printed bag styled as ANNAPURNA'S BREAK FAST MURI 200 loaded with 22.400 kg. Thereafter as per direction of BDO Purulia-I, I opened some portion of bag and found Cannabis/Ganja in this bag. Accordingly I seized the said bag under proper seizure list duly signed

by the public witnesses, police witnesses and accused persons in presence of BDO Purulia-I. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused persons. I also seized one Apache Black and white colour motorcycle bearing Reg. No JH/02AC-9646 from the possession of rider namely Sk Jabir. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrested them. Informed them ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and leveling were done between 20:05 hrs and 23:15 hrs under direct supervision of BDO Purulia-I and CI Sadar, Purulia.

So I started Purulia (M) P.S. Case No 92/17 Dt. 17.04.17 U/S 20(b)(i)/29 NDPS Act 1985 as Suo-motu against the accused persons namely 1) Sk.Jabir s/o Sk. Mustakin r/o Hutmura Ps- Purulia(M), Dist Purulia & (2) Sk.Tufan (29) S/O Abdul ohab of Kantadih, P.S- Jhalda, Dist. Purulia and directed SI Debarbra Chakrobarty for its investigation.
