Sub: Prayer for starting a case U/S 399/402 IPC & 25/35 Arms Act. against the following accd persons and 2/3 others.

In producing herewith the arrested accds persons namely

1. Mosna @ Mahasin Chalak(26) S/O Sk Farid of Hutmura, P.S Purulia(M)
2. Sk. Hasibul (30) S/O Sk. Nisan Ali of Kantadi, P.S Jhalda
3. Sk. Mongla (27) S/O Sk. Pesu of Hutmura, P.s Purulia(M)
4. Md. Amir @ Guddu (24) S/O Md. Sahanbaz of Suklara, P.S- Purulia(M)

All of District Purulia. West Bengal. to the effect that today i.e. on 18/04/17 at 00:45 hrs in course of my mobile duty I received an information from duty officer ASI Alope De that some miscreants were coming from Hutmura end through Purulia- Bankura road by a small vehicle for committing dacoity today night at Dev Filling Station locally known as Bhabani Petrol Pump under Purulia (M) PS with a view to rob away the running cash. After getting this information duty officer diarised the fact in G.D vide G.D.E No.1160 dtd. 18/04/17 and informed the same to O/C, Purulia(M) P.S. As per direction I, ASI Biswajit Bandyopadhyay along with C/611 Jitendranath Pathak, C/974 Dilip Ghosh & N.V.F/405 Falari Kumar rushed near Shyam Sundar Filling station and awaited there for re-enforcement of officers and force from PS. After a while ASI Gurucharan Sahis, C/1139 Jiban Senapati, JC/ 950 Goutam Betej, N.V.F/736 Santosh Singh Mura reached before me and as per order started NAKA checking duty from 01:05 hrs. After some time at about 01:00 hrs found one Bolero vehicle bearing Reg. No. JH10Z/0360 was coming speedily towards the NAKA point. We stopped the vehicle and on searching very carefully & minutely found there are four persons including the driver in the vehicle and 2/3 fled away. On being asked they disclosed their identity as noted above. One Md. Amir @ Guddu (24) S/O Md. Sahanbaz of Suklara, P.S- Purulia(M)(Sl. No.4) Who was driving the vehicle. Searched them very carefully and seized the following articles:-

- i) 01(one) fire arms (pipe gun, local made) loaded with 01(one) round live .303 ammunition from the possession of Mosna @ Mahasin Chalak() S/O Sk Farid of Hutmura, P.S Purulia(M), Dist. Purulia.
- ii) 01 (one) piece of Bamboo Lathi length approx 3' 5" three feet & five inch
- iii) 01 (one) piece of Bhujali length approx 4'(inch)
- iv) 01 (one) piece of Iron Rod length 04'' (four feet)
- v) 01(one) three cell Torch light.

Sl. ii) to v) were kept under the middle seat of the vehicle
And seized the vehicle bearing Reg. No. JH10Z 0360.

As such I seized the above noted articles preparing proper seizure list & labeled duly signed by the accused persons as well as police witnesses in between 02:05 hrs and 02:55 hrs. There was no public witness available on that time.

I asked the detained persons to produce any valid documents in respect of those offending articles as well as reason of their presence at that place during that time. But they failed to produce any valid documents. They also failed to satisfy about their presence at that place during that time. As such it was beyond of doubt that the persons were coming there to commit to dacoity. On interrogation all the accused persons confessed their guilt and stated that they were well known about the possession of Fire Arms but they did not disclose the fled away accused persons. Therefore, I arrested them in-between 03:05 hrs. to 03:25 hrs. them in proper arrest memo and inspection memo after maintaining all formalities as they had committed offence punishable U/S 399/402 IPC and 25/35 Arms Act. found no external injuries on their persons and on interrogation they confessed that they are fit and fine.

Under the above fact and circumstances I request you to lodge FIR and start a case U/S 399/402 IPC & 25/35 Arms Act against the above noted 04(four) arrested accd. and 2/3 unknown others persons who were coming for committing dacoity and arrange its investigation.
