
Respected Sir,

In producing herewith two arrested accds viz. 1) Buddheswar Mahato (35) S/O Thuluchand Mahato and 2) Sudhakor Mahato (45) S/O-Lt. Sasadhar Mahato both of vill Simulia, PS Purulia Mufassil, Dist Purulia under Memo of Arrest and Inspection Memo along with seized articles viz 1) one black coloured zericane having fifteen (15) ltrs of I/D (Cholai) liquor 2) thirty five (26) pcs of bottles of glass in sealed condition having printed paper being affixed on it speaking for itself as Dil Khush, each bottle contains 600 ml of C.S as per logo pasted upon each 3) one bottle of I/D liquor as sample which will testify sl no 1 having 600ml and 4) one bottle of Dil Se as sample being labeled properly, under seizure list I beg to submit that today (24/04/17) at around 18:15 hrs received a telephonic information from my trustworthy source that the above noted accd. persons had a huge stock of I/D liquor and Dil Khush at their shop at Simulia village PS Purulia Mufassil and selling the same illegally. Accordingly I noted the fact in G.D.E. vide Tamna OP under Purulia Mufassil PS GDE no 491 dtd. 24/04/17 and informed the matter to O/C Purulia Mufassil and as per his direction I, S.I Anup Ghosh along with A.S.I Chayan Mahato and available forces as noted in Tamna OP under Purulia Mufassil PS CC no 370/17 Dtd. 24/04/17 left for Simulia village to work out the information by PS vehicle having Rgn No WB-56C-5423 after briefing the fact among my accompanying officer and forces. We reached at Simulia village at 19:05 hrs and keeping the vehicle at a reasonable distance we proceeded towards the shop of said Buddheswar Mahato as led by my source. When we entered into the house two persons seeing the police started running but I with the help of my accompanying officers and forces somehow apprehend the two and on interrogation they revealed their identities as noted above and on searching the house recovered one black coloured zericane having fifteen (15) ltrs of I/D (Cholai) liquor 2) twenty six (26) pcs of bottles of glass in sealed condition having country spirit Dil Khush, each bottle contains 600 ml of C.S as per logo pasted upon each and on demand they failed to produce any license in favour of keeping, storing and selling the same and confessed that they have been running an illegal business of the same for long and hence I seized 1) one black coloured zericane having fifteen (15) ltrs of I/D (Cholai) liquor 2) twenty six (26) pcs of bottles of glass in sealed condition having country spirit Dil Khush, each bottle contains 600 ml of C.S as per logo pasted upon each 3) one bottle of I/D liquor as sample which will testify sl no 1 having 600ml and 4) one bottle of Dil Khush as sample being labeled properly in presence of one public witness Sunil Mahato S/o-Bhabataran Mahato of Vill- Raibandh, PS-Purulia Mufassil, Dist-Purulia and arrested the two accd persons after observing all the formalities regarding arrest as their offence comes under the purview of U/S 46 A(c) of Bengal Excise Act 1909.

So, I Pray Before your administrative desk that a case U/S-46 A(c) of Bengal Excise Act 1909 may kindly be initiated against the accds 1) Buddheswar Mahato (35) S/O Thuluchand Mahato and 2) Sudhakor Mahato (45) S/O-Lt. Sasadhar Mahato both of vill Simulia, PS Purulia Mufassil, Dist Purulia and arrange for its investigation.
