
The above named Complainant begs to

Manbazar Poine Station

- 1. That the complainant is the resident of Village Barabendya, P. S. Jaypur and within the District of Purulia.
- 2. That the complainant is the Registered Owner of one JCB 3DX Backhoe Loader fitted with LDR and the registration number of the same is WB 55A - 4869 and I have purchased the same after taking loan from a Bank.



- That the accused persons came to contact with the complainant and the
 accused persons disclosed that they are Government registered Contractor and
 dealing with the various works under Government and also under various
 reputed Companies.
 - 4. That as per the assurance of the accused persons the complainant agreed to deliver the aforementioned JCB Machine to the accused persons on monthly rent basis and with the said effect an Agreement was executed by the accused No. 1 and the accused No. 2 was the attesting witness, in favour of the Complainant on 16. 01. 2017. As per agreement the accused persons agreed to pay a sum of Rs. 95, 000/- (Rupees Ninety Five Thousand only) per month to the complainant which was payable in four equal installment within the ending of the each month. The complainant also agreed to keep the earlier Driver of the complainant namely Kerumuddin Ansary, for the Machine and to pay the salary, fooding, lodging etc. of the Driver and Cleaner.
 - 5. There were other several conditions were made in the Agreement dated 16.
 01. 2017 executed by the complainant. At the time of taking the delivery of the aforesaid Machine, the complainant have issued a Cheque amounting to Rs.
 25, 000/- from the Account of the accused No. 2 namely Rajnish Bhaskar of Chandradip, Jamui, Bihar who was also an attesting Witness of the said Agreement.
 - 6. That it was the further conditions of the Agreement executed by the Accused persons on 16. 01. 2017 that if the accused persons fail to pay the rent for two months consecutively, the accused persons must returned back the aforesaid JCB Machine to the complainant without fail.
 - 7. That the aforesaid J. C. B. Machine was in works at Manbazar on the date of agreement and the delivery of the Machine was taken place in favour of the accused persons at Manbazar.



- 8. That since the taking of the aforesaid JCB Machine from the complainant, the accused persons did not pay any amount as agreed by them. The accused persons also not responding the telephonic call of my complainant. The complainant also failed to know the where about of his JCB Machine.
- 9. That the complaint sends Notice to the accused persons claiming the amount due and also for the aforesaid machine.
- 10. That it is submitted that the delivery of the aforesaid J. C. B Machine was taken place at Manbazar as the same called for working in Manbazar Doladanga Road.
- 11. That the accused persons are the wrong doer and they should be punished for their illegal and criminal act as per law of the land.
- 12. That the complaint informs the matter to the Superintendent of Police, Purulia on 12. 07. 2017 but till date no steps has been taken by the Police concerns.
- 13. That the accused persons may large in number and search and seizure are required in the case as such the complainant is filing the present petition before the Police for starting a case and for investigation by the agency.

It is, therefore, prayed that your Honour may be graciously pleased to pass an order directing the Officer-in-Charge of Manbazar, Police Station to start a specific case against the accused persons treating this petition as F. I. R and submit report before this Ld. Court.

And the complainant as in duty bound shall ever pray.
