ASI Sk Ali Hussain of Manbazar PS do hereby lodge this complaint regarding that today (22.07.18) at about 18.45 as during my evening mobile received a source in ormation over telephone that the above noted accused person has been selling CS liquor illegally and clandes inely in front of his Goomty infront of Bhurasole Pry School On receiving the reliable source information I communicated with O/C Manbazar PS over telephone and as per his instruction I along with C/1119-Susanta Kr Lingha, C/1184-Subhendu Maity both of Manbazar PS rushed to the spot to work out the information. On arriving to the spot at 18.05 I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any ward paper in support of selling that CS liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanding party in the seizure list and the label. One bottle 375 m CS liquor kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying with ss on seizer list and label .After this I arrested that accuse person namely Shyam Bauri(50)s/o-Lt Bujai Bauri ,vill-Bhurasole, PS-Manbazar, Dist-Puruli safter preparing proper memo of arrest at 18.45 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
