Sir,

I, SI Sujit Das of Manbazar P.S. returned to PS with force and lodged this complaint as suomoto against (1) Lakhindar Bauri (21) S/O Sudhir Bauri of village Udaypur PS Manbazar District Purulia (2) Patit Bauri (56) S/O Lt Jaladhar Bauri of village Udaypur PS Manbazar District Purulia (3) Nitai Bauri (22) S/O Patit Bauri of village Udaypur PS Manbazar District Purulia (4) Muktipada Singh Sardar (27) S/O Prafullya Singh Sardar of village Bansa PS Kenda District Purulia (5) Sudhakar Singh Sardar (36) S/O Lt Sripati Singh Sardar of village Bansa PS Kenda District Purulia (6) Sagar Singh Sardar (20) S/O Chinn Singh Sardar of village Pirrah PS Kenda District Purulia (7) Sk Maanan (28) S/O Sk Azad of village Patharkata PS Manbazar District Purulia (8) Sk Amir (18) S/O Sk Taher of village Patharkata PS Manbazar District Purulia (9) Sk Arman (19) S/O Sk Asgar of village Patharkata PS Manbazar District Purulia to the effect that today i.e. on 26.06.2020 myself along with force were engaged on Mobile duty vide office more at about 12:25 hrs I found that the above persons with their Motor Cycles (03 persons in each Motorcycle) were roaming aimlessly at Manbazar near post office more. Myself alongwith force detained them at Manbazar post office more on Purulia Boro Road under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till date. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalises for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. Moreover they driven the vehicles on public way in rush and negligently as to endanger to human life. I seized:

- i) One Blue colour Pulsar 135LS Motor cycle bearing Registration No. JH05AN/0201 Engine No. JEGBUK49734, Chassis No. MD2JDJDZZUCK00071 Driven by Lakhindar (21) S/O Sudhir Bauri of village Udaypur PS Manbazar District Purulia along with 02 others as noted above in SI No. 2 & 3.
- ii) One Navy blue colour Yamaha Salute Motor cycle bearing Registration No. WB56M/3446 Engine No. E21EE0036368 Chassis No. ME1RE3528H0022917 driven by Muktipada Singh Sardar (27) S/O Prafullya Singh Sardar of village Bansa PS Kenda District Purulia along with 02 others as noted above in SI No. 5 & 6.
