Sir,

I, SI Soamen Kumar Panda of Manbazar P.S. returned to PS with force and lodged this complaint as sumoto against (1) Sasadhar Majhi (55) S/O Lt Jadu Majhi of Noyadilh PS Manbazar District Purulia (2) Tarapada Mandi (30) S/O Goti Mandi of village Nayadilh PS Manbazar District Purulia (3) Baidyanath Hansda (27) S/O Akul Hansda of village Nayadilh PS Manbazar District Purulia (4) Sanjoy Murmu (29) S/O Ashok Murmu of village Jangora PS Bero District Purulia (5) Sufl Hansda (30) S/O Raenjiban Hansda of village Murgadilh PS Bero District Purulia (6) Soamen Murmu (25) S/O Naren Ch Murmu of village Jhatiadilh PS Manbazar District Purulia (7) Seban Singh Sardar (33) S/O Lt Pramchand Singh Sardar of village Kusumikri PS Pancha District Purulia (8) Mathur Singh Sardar (69) S/O Lt Jhanta Singh Sardar of Bhurasole PS Manbazar District Purulia (9) Indrajit Singh Sardar (24) S/O Mathur Singh Sardar of village Bhurasole PS Manbazar District Purulia to the effect that today i.e. on 26.06.2020 myself along with force were engaged on Moofle duty vide Manbazar PS G.D.E No- 1203 Dtd-26.06.20. Accordingly, I had been to Manbazar near post office more at about 16:05 hrs I found that the above persons with their Motor Cycles (03 persons in each Motorcycle) were roaming aimlessly at Manbazar near post office more. Myself alongwith force detained them at Manbazar post office more on Purulia Horo Road under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22/03/2020 which is extended till date. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous in life.

I arrested them for Disobedience to order duly promulgated by public servant, after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. More over they driven the vehicles on public way in rush and negligently as to endanger to human life. I seized:-

i) One Splender plus Motor cycle bearing Registration No. WB56L/0386, Chassis No. MBL11A103GGHFA0653 Driven by Tarapada Mandi (30) S/O Goti Mandi of village Nayadilh PS Manbazar District Purulia along with 02 others as noted above in SI No. 1 & 3.

ii) One Hero Glamour Motor cycle bearing registration No. WB56J/5663, Chassis No. MBL-JA06AMFGK19731 driven by Seban Singh Sardar (33) S/O Lt Pramchand Singh Sardar of village Kusumikri PS Pancha District Purulia along with 02 others as noted above in SI No. 8 & 9.
