In producing here with one accused person Belu @ Bilu sing (32) S/o Lt- Mahadev Sing of village- Dhagora, PO – Dhagora, PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 15 (Fifteen) Ltrs ID liquor within a Jarikan
- (2) 05 pieces plastic glass

I ASI Prasanta Kr. Mandal of Manbazar PS do here by lodged a complaint against accused namely Belu @ Bilu sing S/o Lt- Mahadev Sing of village- Dhagora, PO - Dhagora, PS- Manbazar, Dist- Purulia to the effect that today (19.06.2020) at 16:05 hrs. I received a telephonic information from a reliable source that one Belu @ Bilu sing S/o Lt- Mahadev Sing of village- Dhagora, PO - Dhagora, PS- Manbazar, Dist- Purulia was stocked ID liquor price for his personal gain then I noted this illegally and selling the same to hike information in GD, vide Manbazar PS GDE No-944 Dtd 19.06.2020. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1429 Jagadish Ch. Mahato JC/356 Amit Kr. Dutta rushed to the spot for raid by Govt. vehicle. At about 19:35 hrs. myself along with force reached at Dhagora village and held raid in the house of Belu @ Bilu Sing and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Belu @ Bilu Sing tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Belu @ Bilu sing S/o Lt- Mahadev Sing of village- Dhagora, PO – Dhagora, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
