Sir,

I, SI Sujit Das of Manbazar P.S. returned to PS with force and lodged this complaint as sumoto against (1) Anup Sardar (2) S/O Kalachand Sardar of village Tushyam, PO- Menidih PS Purulia District Purulia 2) Jagadish Baori (21) S/O Biswanath Baori of Baro Jagannathpur PS Manbazar District Purulia 3) Ganesh Baori (22) S/O Lt Biru Baori of village Baro Jagannathpur PS Manbazar District Purulia near Post office more to the effect that today i.e. on 22.06.2020 myself along with force were engaged on Mobile duty vide Manbazar PS G.D.R No-1051, Dist-22/06/20 and CC No-1386, dt-d 22.06.20. Accordingly, I had been to Manbazar near post office more at about 18:05 hrs I found that the above persons with their Motor Cycles, were roaming aimlessly at Manbazar near post office more. Myself alongwith force detained them at Manbazar post office more. On Purulia-Boro Road under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-L(A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete resumption measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till date. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to COVID.

I arrested them for Disobedience to order duly promulgated by public servant, after maintaining all rules of arrest, issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 118 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. More over they drove the vehicles on public way in rash and negligently so as to endanger to human life.

driven by Anup Sardar (2) S/O Kalachand Sardar of village Tushyam, PO- Menidih PS Purulia District Purulia with proper seizure list duly signed by the accused persons and witnesses.

All the process was done in between 18:45 hrs . There was every chance of breach of peace and requiring arrest offence if not arrested. As there was lock down in the town the people left the place and did not agreed to come forward to remain present as witness in the seizure process. I also restrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar through duty officer SI Indrajit Sarker for taking necessary action as per law. I handed over all the relevant papers, seizure list, seized motor cycles, Memo of arrest, Inspection Memo.
