Sub: Complain to start a specific case.

Sir,

I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against Bapi Bauri (approx 35 years) S/O- Lt. Rampada Bauri of Vill-Raghudih, PS-Neturia, Dist-Purulia that as per Government order and as suggested by BMOH, Harmadih, he has been shifted to Janardandih High School today from 15:00 hrs as institutional quarantine as he came from Gujarat state. But during our mobile duty I received information from on duty CVF Debdas Paramanik that the said Bapi Bauri came out from the institutional quarantine center i.e. Janardandih High School after jumping from back side boundary wall and moving at Janardandih market with a view to purchase Birj. While I along with force reached at Janardandih at about 18:05 hrs and found that Bapi Bauri was moving in public place at Janardandih market. I requested him to go back at quarantine center but he refused. After humble request several times, he returned back to quarantine center i.e. Janardandih High School. The matter was informed to you over cell phone from the place of occurrence.

So there is every reason to believe that the above noted accused person came out from institutional quarantine center and violated the order during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule.

Therefore, I pray a specific case may kindly be started against Bapi Bauri (approx 35 years) S/O- Lt. Rampada Bauri of Vill-Raghudih, PS-Neturia, Dist-Purulia as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S- 188 IPC. and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
