Sir,

I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against Anjay Kumar Shaw (36) S/O- Lt. Sitaram Shaw of Vill-Saltore Bazar, PS-Neturia, Dist-Purulia, Owner of Anmol Basanalay, Parbelia Bazar that today on 27.02.2020 while I along with force C/382 Bipad Taran Chatterjee, C/1304 Dhananjoy Mondal and C/66 Kameshwar Pandey all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazar at about 18:05 hrs found that the above noted person selling utensils in his shop without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation.

So, there is every reason to believe that the above noted accused person selling utensils in his shop without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against Anjay Kumar Shaw (36) S/O- Lt. Sitaram Shaw of Vill-Saltore Bazar, PS-Neturia, Dist-Purulia as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule U/S- 188 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
