I, SI Bablu Ghosh of Neturia PS, Dist- Purulia do hereby lodge a written complaint against Rameswar Mukharjee (Approx 50 years) S/O- Nityananda Mukharjee of Vill-Benipur, PS-Neturia, Dist-Purulia, Owner of Maa Lakhi Grocery Shop at Jhanka Morh to the effect that today on 28.06.2020 while I along with force JC- 13 Viswa Jali and JC- 17 Basak Roy both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 1193 and CC No- 1805/20 dated 28.06.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Jhanka morh at about 18:45 hrs found that the above noted person was selling Goods to the customers in his shop without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation. I took photograph of the grocery shop along with owner in presence of customer Suraj Bouri S/O- Lt. Ajit Bouri and Sanjay Nath S/O- Nimai Nath both of Vill-Monpura, PS- Neturia, Dist- Purulia and other customers left the place on seeing the Police team.

So, there is every reason to believe that the above noted person was selling Goods in his shop at Jhanka Morh under Neturia PS without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against accused Rameswar Mukharjee (Approx 50 years) S/O- Nityananda Mukharjee of Vill-Benipur, PS-Neturia, Dist-Purulia U/S- 188 IPC and 51 (1) (b) Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
