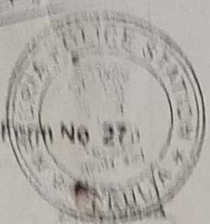

Sub: Prayer for starting a specific case under proper section of law.

Sir,
With due respect and humble submission, I do hereby lodge a written complaint against 100/150 unknown supporters of Bharat Jakat Majhi Pargana Mahal, Neturia Muluk to the effect that today on 24.09.18, myself along with ASI Bidhan Chandra Mondal, ASI Deb Kumar Chattaraj, ASI Abu Akher along with other force were engaged to perform L/O duty at Haridih More in e/w road blockade & rail roko programme called by Bharat Jakat Majhi Pargana Mahal vide Neturia PS CC No-3078/18 and GDE No- 1071/18 Date: 24.09.18.

At 06:00 AM about 100/150 unknown supporters of Bharat Jakat Majhi Pargana Mahal, Neturia Muluk being armed with deadly weapons like lathi, tangi, axe etc blocked the Purulia - Barakar pitch road (SH-5) and started to raise slogans regarding their various demands.

After a prolong waiting I have tried to pursue the agitators to withdraw the blockade and help police to disperse the mob as well as discharge lawful duty. It was also found more than 120/130 vehicles loaded with goods and loaded with passengers and drivers including patients etc. from Purulia Side and Barakar side were detained there and subjected to enormous sufferings for a long time. The above accused persons continued to be with the unlawful assembly, causing unlawful restraint to the vehicles & passerby and thus generated danger & obstruction in state highway and also caused obstruction to police in discharging Govt. duty, in spite of several time persuasion, they did not pay any heed.

At about 17:05 hrs, I along with other officer and force again tried to pursue the agitator to withdraw the blockade. During persuasion a hot altercation took place with them and they started scuffling and used criminal force to police party with an intention to prevent or deter the police party from discharging our duty being a public servant in the execution of our public duty as such public servant. At about 18:15 hrs the road blockade was withdrawn.

Under the above circumstances a specific case may kindly be started against 100/150 unknown supporters of Bharat Jakat Majhi Pargana Mahal, Neturia Muluk under proper section of law.
