Sub: Prayer for starting a specific case under proper section of law.

Sir,

In producing herewith one seized truck bearing registration No – WB 81/0653, Chassis No-MAT541006F3P25494 & Engine No-51L63482254 loaded with raw coal of 16 M.T. (approx) do hereby lodge a complaint to the effect that on (19/06/2020) I, ASI Jhantu Dalal along with C/1140 Dayamoy Mahato, C/480 Uttam Bauri and C/1260 Santosh Saren all of Neturia PS were engaged in day mobile duty at Sarbari More vide Neturia PS GDE No- 788 Dt. 19.06.2020 & CC No- 1700/20 Dt. 19.06.2020. In course of mobile duty at about 14:25 hrs received credible source information that one truck bearing no – WB 81/0653 loaded with illegal coal is coming from Gram Parbelia side and will transport the same to Raghunathpur side through Purulia – Barakar road in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force left for Gram Parbelia and while we were reaching at Gram Parbelia at about 14:45 hrs, found that one vehicle was coming from Gram Parbelia side. Suddenly the vehicle stopped about 70/80 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards the jungle side. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding area to find out the person but failed to trace out him. On search we found that the vehicle (Truck) bearing registration No – WB 81/0653 loaded with raw coal of 16 M.T. (approx) is matched which was given by my source.

So, there is reason to believe that the driver, owner of coal and registered owner of the vehicle have collected the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they are trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly I seized the vehicle (Truck) bearing registration No – WB 81/0653 loaded with raw coal of 16 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 15:35 hrs to 15:55 hrs, since no public witness was found.

Under the above circumstances a specific case may kindly be started against the (1) driver of vehicle No- WB 81/0653 (2) owner of the coal, seized from vehicles No- WB 81/0653 and (3) Registered owner of vehicle No- WB 81/0653 under proper section of law.
