Sir.

In producing here with 03(Three) arrested accused persons namely (1) Mantu Bauri(32), S/O- Lt. Bechan Bauri of vill-Pedda, PS-Manbazar, Dist-Purulia (2) Kalipada Sen(24), S/O- Lt. Ajit Sen of vill- Kamalpur, PS Khandaghosh, Dist-Purba Bardhaman (3) Swapan Bauri (30), S/O- Lt. Bhabotosh Bauri of vill Mukndpur, PS- Puncha, Dist. Purulia along with seized motor Cycle Bajaj Platina bearing Regn. No WB56P/7950, seizure list, Memo of arrest & other relevant papers.

I beg to state that today (26.06.2020) at 15:15 hrs. I was engaged in mobile duty at Gokulnagar area with special mobile officer and force to find out whether the lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 1402 Dtd. 26.06.2020 and CC No-1810 Date-26.06.2020. Accordingly, I was performing duty Gokulnagar area. At about 16:15 hrs I found that the above noted persons with their Motor Cycle, were roaming aimlessly at Gokulnagar Naka point area. I along with force detained them at Gokulnagar Naka point on Manbazar-Bankura road under Puncha PS. On being asked the above accused persons could not give any satisfactory answer for that movement on road and public place. They were also driving the motor cycle on public way without headgear. On being asked they did not produce the valid documents in respect of said motor cycle as well as and all the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also rode negligently to spread infection of disease dangerous to life. There was every chance of breach of peace and repeating of offence if not arrested. They disobeyed the order duly promulgated by Govt. through public servants and through media etc. for prevention of attack from Corona virus/Covid-19. They were creating annoyance to the society & violated Govt. order.

They disclosed their identity as noted above but cannot give satisfactory answer about their such type of activities and running motor cycle three persons in one motor cycle(without wearing mask and without maintaining social distance) having Reg. No. WB56P/7950 and without using headgear. Finding no other alternative I arrested them for disobedience to order duly promulgated by public servant; after maintaining all formalities. Issued Arrest Memo. I informed them the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. At prima facie there were sufficient grounds to secure their detention. I also seized their vehicle, i.e. one Bajaj Palitina motor cycle bearing registration no- WB56P/7950 under proper seizure list duly signed by the accused persons and witnesses. All the process was done in between 16:15 hrs and 17:15 hrs. I offered them bail but they could not produce any surety.

As there is lock down in the area the peoples left the place and did not agreed to come forward to remain present as witness in the seizure process. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

Therefore, I pray that a specific case may kindly be started against ((1) Mantu Bauri(32), S/O- Lt. Bechan Bauri of vill-Pedda, PS-Manbazar, Dist-Purulia (2) Kalipada Sen(24), S/O- Lt. Ajit Sen of vill- Kamalpur, PS Khandaghosh, Dist- Purba Bardhaman (3) Swapan Bauri (30), S/O- Lt. Bhabotosh Bauri of vill Mukndpur, PS- Puncha as they disobeved Govt. order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/269/270/34 IPC and Sec 51(a)(b) of National Disaster Management Act, 2005 and also driving of motor cycle on public way without headgear U/S 128/129/177 of MV Act and arrange for its investigation,
