Sir,

I, Shri Partha Pratim Kirtaniya, B.L.&.L.R.O, Manbazar-I, do hereby lodge complaint against (1) Sri Biswarup Roy and (2) Sri Bankim Roy of Vill.: Simchaka, who claim themselves to be the owner of Tractor (bearing Registration No. WB 55A /3842) alongwith with a Trailer was found carrying Sand illegally and in contravention with the provisions of Sec 4(1A) of the the Mines & Minerals (Development & Regulation) Act, 1957 Read with Rule 3(b) of the The WBMM Concession Rules, 2016 and Rule 3 of the West Bengal Minerals (Prevention of Illegal Mining, Transportation and Storage) Rules, 2002 on 16.09.2016 at about 6 a.m. in the morning at Polmi Ghat under the jurisdiction of the BL&LRO, Manbazar - I, Dist.-Purulia when the undersigned designate alongwith the Block Development Officer, Manbazar - I and the Joint Block Development Officer, Manbazar - I was on raid duty. The afore mentioned vehicle was seized in accordance with the provisions of Sec 21(4) of the MMRD Act, 1957 read with Notification No. 88-CI/Gr. D/4M-30/88 dated 24.01.1991 issued by the Government of West Bengal in the Commerce & Industries Department and the vehicle has been kept under the safe custody of the Officer-in-Charge, Puncha Police Station.

However, the owners or their authorised legal representatives did not turn up for compounding of the offence committed afterwards. I would, therefore, request you to treat this complaint as an F.I.R. and prosecute the offenders under the law in force and take necessary steps .

I am duly authorized by the Government of West Bengal to lodge complaint u/s 22 of the Mines and Minerals (Regulation and Development) Act, 1957, in terms of Notification No. 89-GI/Gr-D/4M-30/88 Dated 24.01.1991
