Sub: Prayer for starting a specific case

Respected Sir,

In producing herewith arrested accd namely Raju Sao (34) S/O Bindheswari Sao of Vill Niyamatpur, PS Kulti, Dist Burdwan under arrest Memo and Inspection Memo and seized articles VIZ (1) One Truck having Reg. No. WB-37B-6379 loaded with coal(approx 10 MT) (2) 2 kg of coal from the vehicle as sample.

I beg to report that today (07.03.17) I was performing mobile duty at PS area along with C/921 Madhusudan Baral C/935 Sahadeb Majhi Vide CC No. 428/17. During mobile duty, at around 19:25 hrs while we were at Napara more , found one truck being loaded with something, was going towards Puncha side and seeing us the driver of the vehicle picked up its speed and tried to flee away suspiciously and accordingly we started chasing the vehicle. We intercepted the truck near Damodorpur village and the driver of the vehicle tried to flee away by jumping up from the truck but we apprehended him. On interrogation he revealed his identity as Raju Sao, S/O Lt.Bindheswari Sao of Vill Niyamatpur, PS Kulti, Dist Burdwan and confessed that he was carrying coal without any valid papers but he did not disclose how and from where he procured the coal and he gave different statement on different time and even he could not give any papers of the truck having RGN No WB 37B-6379. From his behavior and outer manifestation it was evident that he procured the coal and the truck by means of theft and he is a habitual dealer of such type of stolen goods and he was trying to flee from the clutch of police only to conceal the stolen property. Accordingly I seized the truck bearing RGN NO WB 37B-6379 being loaded with coal of approximate 10 MT and also seized 2 kg of coal from the vehicle as sample, under proper seizure list and being labeled properly and it is to be noted that no public witness could be made available during seizure. The seizure was completed at 20:45 hrs and after seizure I arrested him observing all the formal steps regarding arrest. It is further to be noted that due to unavailability of weight bridge at the locality the exact weight of the coal could not be measured , instead the statement of the accd was considered .

Hence I would like to request you to start a specific case against the above noted arrested accd person may kindly be started under proper section of law and arrange for its investigation.
