Most respectfully sheweth :-

- 1) That the complainant is the legally married wife of Jannat Ansary i.e. the accused No. 1.
- 2). That their marriage was solemnised on 19.03.2016 according to the Muslim Rites and customs.
- 3). That at the time of marriage complainants parents provided all demands of the Jannat Ansary and his family members like cash of Rs. 50,000/- and others the list of the articles are enclosed with this petition.
- 4). That after marriage the complainant started to reside at her matrimonial house at Village - P.O. Pancha, P.S. Pancha Dist - Purulia with her husband along with his family members.
- 5). That at her matrimonial house, her husband Jannat Ansary father-in-law Kaum Ansary, Mother-in-law Jaibun Bibi, brother in law Saad Ansary, Sister in law Subhan Bibi, Sister in law Farveed Ansary, Feroz Ansary and Latif Bibi resided with complainant for

bringing extra dowry of Rs. 20,000/- from the father's house of the complainant's ~~father's house of the complainant~~. But on the day of marriage complainant's father fulfilled all demands of the matrimonial house members ~~and the complainant~~ and i.e. why at this moment they have no capacity to fulfill extra dowry, Later the matrimonial house members of the complainant torture her in mentally and physically.

6. That Later accused No. 1 Jannat Ansary took the complainant from Lucha to Durgapur at a rented house where her husband. Jannat Ansary was a worker under Birla Ambuja Cement factory.

7. That at Durgapur complainant's husband forced her ~~by~~ in physically and mentally for bringing extra dowry of Rs. 20,000/- <sup>The costume was like</sup> ~~like~~ beat her by Lathi.

8. That as the complainant did not pay heed to the words of her husband so, her husband abused the complainant and her parents.

9. That when the complainant used to come to her matrimonial house at Lucha where the above named matrimonial house member torture her by lathi for bringing extra dowry of Rs. 20,000/- from her father's house and they did not pay heed to the words of excuse of the complainant that at the time of marriage complainant's father's house fulfilled all demands of dowry that is why at that moment they <sup>were</sup> unable to fulfilled extra dowry demand.

10. That on 16.07.2016 the complainant's husband Jannat Ansary forced the complainant for bringing extra dowry of Rs. 20,000/- from her father's house but the complainant was not agree to go her father's house for bringing extra

dowry so, her husband took one sharp knife and cut left hand of the complainant so, huge bleeding was ~~fallen~~ from her left hand of the complainant as a result the complainant was injured and to save her life, she immediately informed her father's house and after hearing this news her parents took her from Durgapur to Furulia and later Tata Nisha General hospital for provide her proper medical treatment.

11. That as the complainant was pregnant but due to ill treatment and instruction of her husband Jannat Ansary, father in law Naum Ansary, mother in law Jaibun Bibi, brother in law Muslim Ansary, Sister in law Subhana Bibi, Sister in law's husband Parvej Ansary, Firoj Ansary and Samta Bibi, the complainant was bound to do abortion on 20.07.2016.

12. That after cure her, Her Parents to give shelter to the complainant at their residence and from then to till today the complainant has been residing with her parents, but in the meantime the matrimonial house members did not take any information regarding the complainant that she was alive or not ?

13. That later the complainant informed the whole incident to the P.S. authority of Durgapur and Pancha P.S. as well as S.P. Furulia but got no relief.

14. That that is why the complainant is liable to take shelter before the Court of Law for Justice.

It is respectfully prayed that your Honour would be please to accept the petition U/s 156(3) C.P.C. and directed to Pancha P.S. to treat the same as a F.I.R. and be please to pass necessary order. A & D
