



That in reply the complainant told to her matrimonial house members that at the time of marriage her father sold some land to fulfill the dowry demand ~~if~~ is why, at that time he is unable to fulfill the extra dowry demand then complainant husband Rabilochan Paul, brother-in-law Arabinda Paul, Sister-in-law Priya and her husband Satyajit abused the complainant in filth language even after beat her by lathi, and the complainant is helpless, So she bear it such an insult.
8. That later the complainants husband forced the complainant for bringing extra dowry of Rs.20,000/-

So, the complainant immediately informed this matter to her father's house and within few hours her father, uncle (Jethu) reached the door of Rabi Lochan Paul and took the complainant to Vill. & P.O. Palma, P.S. Puncha Dist. Purulia.

10. That the complainant informed this matter to local P.S. but got no relief.

11. That from then to till today the complainant has been residing at her father's house and in the meantime her husband neither visit at her matrimonial house nor take any information about her wife.

12. That a few days ago the complainants husband Rabi Lochan Paul filed a Divorce Suit before A.D.J.Court of Raghunathpur. against the complainant.

13. That the complainant has gone to local P.S. as well as S.P. Purulia but after exping of more than 10 days no action has been taken by either P.S. authority or S.P. Purulia.

14. That that is why the complainant is liable to take shelter before the court of law for justice.
