Sub: Request for lodging F.I.R. against accused Paresh Mandal s/o- Nabakishor Mandal of Bagda Madhyam Para near old Bank, PS- Puncha Dist- Purulia u/s- 46A of B.E. Act 1909.

Sir,

In producing herewith seized articles viz. (i) One black colour plastic jarican having approximate 20 ltrs. I.D. liquor (ii) 2(Two) plastic empty bottle (iii) 5(five) plastic glasses I S.I. Debakar Kuiri of Puncha PS do here by lodge complaint to the effect that today i.e. on 21.03.17 at around 17.05 hrs. received from Credible source information that one person namely Paresh Mandal of Bagda village from is selling id liquor illegally and stored huge quantity of ld liquor in his house illegal I.D. liquor. Accordingly the above source information informed to P/C Puncha PS and as per his direction myself along with accompanying available forces as well as evening mobile officer ASI Jaydev Gorai and force all of Puncha PS had been to said place to work out the source information. At around 17.35 keeping our vehicle in a safe distance when we proceeded on foot to the house of Paresh Mandal and found that the information is true. On seeing police personal the accused person namely Paresh Mandal fled way on the spot. During search and verification the above noted seized articles have been recovered from the place and seized under proper seizure list in presence of witnesses namely (1) Manaranjan Mandal @ Buka, S/O-Paresh Mandal of Bagda, PS-Puncha, Dist. Purulia (2) Bijoy Mahato, S/O-Lt. Rampada Mahato of Hatiher, PS-Puncha and (3) Papan Chatterjee, S/O-Bhaskar Chatterjee of Bagda, PS-Puncha, Dist. Pruuulia I collected one and also took sample of the id liquor and labeled properly.

Under the above fact and circumstance I pray before your good self that a specific case under proper section of law may kindly be started against the accused Paresh Mandal, S/O- Nabakishor Mandal of Bagda, PS-Puncha, Dist. Purulia for its regular investigation.
