I the undersigned would like to inform you that I have enter into a Partiership Deed, which was registered, vide Sl. No. 398 / 15 dated 31/12/2015 with Sazid Hussain Ansary and Ranjit Mandal on certain terms and conditions stated therein.

That a work order was issued being Ref. No. NIT No. WBIW/OSD(SE)/PRL/NIT-30(e)/2015-16. (NIT No. WBIW/OSD(SE)/PRL/NIT-18(e)/2015-16. St. No. o1) and letter dated 23/32/2015 from the office of the officer on special duty (Superintending Engineer) Sharbandh Irrigation colony. Purulia, in favour of Sazid Hussain Ansary and by virtue of the Partnership deed, we all the three partners started to execute the work of three CHECK DAMS at Puncha Block, within Puncha P.S, Dist- Purulia by investing the capital as per the conditions.

That after few days due to some inadvertence the 2nd partner namely Ranjit Mondal withdraws himself from the duties and liabilities from the business of the partnership firm by settling his accounts and we the two partners started to continued the said partnership business.

That, after retirement of the 2nd partner, several request were made to Sazid Mussain Ansary for execution of a new partnership deed with the share of 50% each, but Sazid Hussain Ansary each and every time avoided the same with intend to deceive me That it is pertinent to mention here that the Partnership deed was not in accordance with the terms and conditions as per our oral discussion and traudulently my signatures

were obtained by giving false representation. That after 90 percent completion of the job as per the work order said Sazid Hussain Ansary received payments about Rs. 2 Crore, but did not pay me the actual share.

That on request to make payment of my share, Said Sazid Hussain Ansary abused me in filthy languages and finally denied to make any payment and told me to do whatever I want.

In the circumstances it is set forth above that Sazid Hussain Ansary, by hatching a criminal conspiracy, with intend to deceive me, dishonestly induced me to invest in the business and cheated me and causing wrongful loss to me and wrongful gain to himself, dishonestly misappropriate the property of the firm and also committed other offences.

In this regard you are requested to take appropriate legal action against Sazid Hussain Ansary.
