The above named complainant beg to state as follows:-

1. That the complainant, accused persons and witnesses are resident of village Patharkata under p.s. Funcha District Purulia.
2. That the land described in the schedule of the petition is situated in mouza Budpur of R.S. khatian no. 12 and the names of Kuyar Mahato and his two brothers ~~xxx~~ have been recorded in the last R.S. operation and to aboid any future dispute, after R.S. operation above named three brothers amicably decided the schedule land with other lands in three equal parts and after settlement ^{Kuyar} ~~Kuyar~~ Majhi is/was in possession over the schedule land along with other land without any concern with others.
3. That when Kuyar Majhi was in possession over the schedule land due to his urgency and to meet up loan money, he sold out the schedule land with other lands to the complainant and his brother vide Registered Deed no. 2775/1984 and also give delivered possession

to them and since the date of purchase vandeas are in possession over the schedule land and other lands as per deed. Be it mentioned here youngest brother of the complainant namely Baburam Kisku died unmarried stage without any issue and the share of Baburam devolved upon his other two brothers who are the complainant and witness no. 2.

4. That like other years the complainant partly transplanted paddy plant within the land mentioned in schedule below in the cultivation season.

5. That while the paddy was riped and fit for harvesting then on 10.12.2016 at about 6/00 A.M. the above named accused persons most illegally and wrongfully entered into the schedule land with deadly weapons and have started harvesting paddy, Hearing the news the present complainant rushed to the schedule land and also protested the illegal acts of the accused persons, but they did not pay any heed to the request of the complainant and on the other hand accused persons assaulted the complainant by fist and blow, Then the complainant makes a noise by saying Banchao... Banchao

Hearing the news the witnesses came there and saved the complainant from the hands of the accused persons. Then the accused persons left the place with dire consequence after removing all the paddy from the schedule land
