I do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Sri Subodh Ch. Das S/O Digambar Ch. Das of Vill-Siholi, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 05.01.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E) S/O Sri Pradip Kumar Maity, Ajit Kumar Mahato (L.M.), S/O-Lt. Lambodar Mahato, Sri Jogeswar Mahato (L.M.), S/O-Lt. Nutan Mahato of Telkalpara CCC, and Md. Jiaur Rahaman Mandal, AE(E) Dayamay Mahato (TSH) of S&LP Unit, Purulia Region, WBSEDCL conducted a raid programme. at village Siholi under Purulia(M) P.S. When our team at about 02.30 P.M entered to the Domestic premises of Subodh Ch. Das, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run heater in kitchen, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, at first disconnected the wire with hooking arrangement from LTOH line and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 03.00 P.M after completion of inspection & necessary formalities.

Sri Subodh Ch. Das S/O Digambar Ch. Das of Vill-Siholi, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
