Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No. WB55/8064 loaded with sand. The fact of the case in brief is that on 11/01/2017 night I along with force were on special raid duty at Mutrudi side. During raid duty on 12.01.2017 at about 02:45 hrs received a credible source information that the above noted (Tractor) is coming from Mutrudih side loaded with sand. After receiving this information we were proceeding towards Mutrudih river bed under Purulia(M) P.S. When we reached near Ramkrishna Tarakmath under Purulia(M) P.S, found that the above noted (Tractor) was coming from Muturudi side. On seeing the Police party the driver of the said tractor fled away after keeping the tractor near Tarakmath on Ketika-Mutrudi kancha road at 04:25 hrs. We searched the said tractor and found that the said Tractor is loaded with sand. I also searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents of that tractor but nothing found. Hence I seized the tractor bearing registration No WB55/8064 loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Purulia (M) P.S. As such there is every reason to believe that the driver, and owner of the vehicle bearing registration No WB55/8064 with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) bearing registration No WB55/8064 may kindly be started and arrange for its investigation.
