Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No. WB55A/4345 loaded with sand. The fact of the case in brief is that on 11/01/2017 night I along with force were on night mobile duty on Purulia- Ranchi road. During mobile duty on 12.01.2017 at about 03:35 hrs received a credible source information that the above noted (Tractor) is coming from Bhul side towards Belkuri side loaded with sand. After receiving this information we were proceeding towards Belkuri morh under Purulia(M) P.S. When we reached near Belkuri morh under Purulia(M) P.S, found that the above noted (Tractor) was coming from Bhul side. On seeing the Police party the driver of the said tractor stopped the tractor in a distance from Belkuri morh and tried to unload the sand loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near Belkuri morh at 05:15 hrs. We searched the said tractor and found that the driver of the said Tractor is able to unload half tractor of sand. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the tractor bearing registration No WB55A/4345 loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Purulia (M) P.S. As such there is every reason to believe that the driver and owner of the vehicle bearing registration No WB55A/4345 with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) bearing registration No WB55A/4345 may kindly be started and arrange for its investigation.
