Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No. WB 55A/5497 attached with Trolley loaded with sand. The fact of the case in brief is that on 02/05/2017 during mobile duty on acting a source information I along with force were proceeding towards Ketika Palanja village area under this PS. When we reached near Palanja village area at about 10.15 hrs found that the above noted (Tractor) was coming from Nadi Ghat towards Purulia Town on the Morum road . On seeing the Police party the driver of the said tractor stopped the tractor in a distance from Palanja village more and the driver fled away after keeping the tractor near the Palanja village more . We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the sand but none turned up and demanded that he is the actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business . so seized the tractor bearing registration No WB55A/5497 loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Purulia (M) P.S. So it reason to belief that they procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Reg. No WB55A/5497
