Respected Sir,

In producing herewith arrested accused persons namely (i) Ganesh Mahato (63), S/o- Lt. Shankar Mahato and (ii) Kirtan Mahato (64), S/o- Lt. Badal Mahato both of of Vill.- Baligara, P.S.- Purulia(M), Dist.- Purulia along with seized articles as per seizure list.

I beg to submit that on today 03/05/2017 in between 18.55 hrs to 19.45 hrs. in course of special raid duty acting of a secret source information myself along with force conducted raid in the house of Ganesh Mahato (63), S/o- Lt. Shankar Mahato of Vill- Baligara, PS- Purulia (M), District - Purulia at Baligara and found that the above noted persons were selling country spirit at the house of Ganesh Mahato (63), S/o- Lt. Shankar Mahato conjointly with Kirtan Mahato (64), S/o- Lt. Badal Mahato of same village. On demand they failed to produce any valid document in respect of keeping and selling of liquor in the house of Ganesh Mahato. On search at the house of Ganesh Mahato found (1) 30 (thirty) sealed bottles of Country Spirit styled as DIL KHUSH each Bottle contains 600 ml 2) 15 (Fifteen) sealed bottles of Country Spirit styled as DIL KHUSH each bottle contains 375 ml. 3) 02 (two) container full of country Spirit contains 20 Lts. each and I seized the above noted country spirit under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accused persons after informing them the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses.

The above noted arrested accused persons namely (i) Ganesh Mahato (63), S/o- Lt. Shankar Mahato and (ii) Kirtan Mahato (64), S/o- Lt. Badal Mahato both of of Vill.- Baligara, P.S.- Purulia(M), Dist.- Purulia committed offence u/s 46 A ( c ) B.E. Act. 1909 for unauthorized possession and sale of country spirit from the house of Ganesh Mahato.

Under the fact and circumstances I therefore pray before you kindly do the needful against accused persons namely (i) Ganesh Mahato (63), S/o- Lt. Shankar Mahato and (ii) Kirtan Mahato (64), S/o- Lt. Badal Mahato both of of Vill.- Baligara, P.S.- Purulia(M), Dist.- Purulia.
