Sir,

In producing herewith one arrested accd. person namely Bablu Acharjee (55) S/O- Lt Narayan Chandra Acharjee of Vill- Belguma Jagadanandapally, PS- Purulia (M), District - Purulia with seized articles (1) 20 (twenty) sealed bottles of Country Spirit styled as DIL KHUSH each bottle contains 600 ml 2) 15 (Fifteen) sealed bottles of foreign liquor styled as DIL KHUSH each bottle contains 375 ml. 3) 10 (Ten) sealed bottles of foreign liquor styled as Mc. Dowell RUM each bottle contains 500 ml, 4) 12 (Twelve) sealed bottles foreign liquor styled as Mc. Dowell RUM which were seized under proper seizure list.

I beg to submit that today (12.01.2017) in between 19.05 hrs to 19.35 hrs during special raid duty acting of a secret source information myself along with force conducted raid in the grocery shop of Bablu Acharjee (55) S/O- Lt Narayan Chandra Acharjee of Vill- Belguma Jagadanandapally, PS- Purulia (M), District - Purulia and found that the above noted person is keeping and selling country spirit and foreign liquor which were kept in grocery shop. On demand he failed to produce any valid document in respect of keeping and selling of liquor from the grocery Shop. As such I seized (1) 20 (twenty) sealed bottles of Country Spirit styled as DIL KHUSH each bottle contains 600 ml 2) 15 (Fifteen) sealed bottles of foreign liquor styled as McDowell RUM each bottle contains 375 ml. 3) 10 (Ten) sealed bottles of foreign liquor styled as McDowell RUM each bottle contains 375 ml. 4) 12 (Twelve) sealed bottles of foreign liquor styled as McDowell RUM under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presece of witnesses.

The above noted arrested accd. namely Bablu Acharjee (55) S/O- Lt Narayan Chandra Acharjee of Vill- Belguma Jagadanandapally, PS- Purulia (M), District - Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of foreign liquor and country spirit from his grocery Shop.

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Bablu Acharjee (55) S/O- Lt Narayan Chandra Acharjee of Vill- Belguma Jagadanandapally, PS- Purulia (M), District - Purulia and arrange for its investigation.
