I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Uttam Deogharia S/O Chitta Deogharia of Vill -Charra,Namo Khannadih, PS-Purulia(M)has committed theft of electricity under section 135 (1) (a) as detailed here under.

Today, i.e. on 05.05.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E) of Telkalpara CCC & Jiaur Rahaman Mondal,AE(S&LP) .Sankar Chandra Mahato,L.M., and Dayamay Mahato,TSH of Purulia Region ,WBSEDCL conducted a raid programme. at village Charra,Namo Khannadih under Purulia(M) P.S. When our team at about 02.40 P.M. entered to the Commercial premises of Uttam Deogharia, we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LTOH Line and run Toto charging machine, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses ,Hooking wire dismantled and seized and seizure list prepared .The seized material labelled in presence of the local witnesses. The inspection team left the aforesaid location at about 03.00 P.M. after completion of inspection & necessary formalities.

Uttam Deogharia S/O Chitta Deogharia of Vill -Charra,Namo Khannadih, PS - Purulia(M) has committed theft of electricity under section 135 (1) (a) of the Electricity(Amendment) Act-2007.
