Sub: Prayer for lodging FIR.

Sir,

I SI Anup Ghosh S/o -Subal Ghosh permanent resident of Vill+P.O.-Bhasara, P.S- Keshiary, Dist-Paschim Medinipore, presently attached to Tamna O.P. as in-charge under Purulia (M) P.S. Dist-Purulia do hereby lodge a complaint as suo-motu against (1) Malati Mahato W/o-Bhruguram Mahato of Tamna (Mahato Para) , PS-Purulia(M), Dist-Purulia (2) Latika Sing Sardar S/o—Bhim Sing Sardar of Tamna (Sardar Para) , PS-Purulia(M), Dist-Purulia and approx 100 unknown villagers (women) of Tamna, Tamna Sardardih and Tamna Mahatopara of Chakoltore GP under Purulia (M) PS Dist- Purulia, that today (06.05.2017) at 10.00 hrs getting information regarding sudden gathering of people at Tamna near Ruchika Hotel on Tata-Purulia National Highway, the matter is informed to O/C Purulia (M) PS as well as diarized vide Tamna OP GDE No-127 Dtd-06.05.17. Accordingly myself along with ASI Chayan Mahato and force went to Tamna and found that approx 100 unknown villagers (women) of Tamna, Tamna Sardardih and other villages of Chakoltore GP had obstructed Purulia - Tata (NH 32) road at Tamna near Ruchika Hotel under Purulia (M) PS and vehicular traffic was getting disrupted. Ongoing buses, trucks and other vehicles were stopped remitting all people got stuck. They raised slogans against the Govt. for anti people policy. A tumultuous situation occurred and after several request of me, the agitators did not pay any heed to withdraw the blockade. Finding no alternative I declared the mob as unlawful assembly and asked them to disperse, though they did not pay any attention. As we were scanty in number, so I prayed for reinforcement.

Meanwhile, , Dy. S.P. (H/Q) Purulia, , C.I. (Balarampur), Purulia and O/C Purulia (M) PS Shri Dibyojyoti Das B.D.O.Purulia-I Development Block with re-enforcement arrived at this spot and after prolonged discussion with them they withdrew the blockade at 13:25 hrs and decamped calmly. Vehicular traffic became normal.

As those persons have committed an offence U/S-143/341/186/283/506 IPC & 18 W.B. Highway Act 1964, hence I submitted a complaint with a prayer to start a specific case U/S- 143/341/186/283/506 IPC & 18 W.B. Highway Act 1964 and for its investigation.
