Sub: To start a specific case.

Sir,

I SI Sunil Kr. Banerjee of Purulia (M) PS, Dist-Purulia do hereby lodge a suo moto complain after arriving at PS that today 02.06.2020 I along with force was performing special mobile duty at PS area by Purulia (M) PS GDE No-55 dtd- 02.06.2020 and special CC No-182/2020 dtd- 02.06.2020 received a telephonic information from duty officer of Purulia (M) PS regarding road blocked at Golkunda more on Purulia-Barakar road (SH-5) and the road was obstructed by the villagers of Golkunda village, Mamurjore village over the issue of the changing of fiddler of Electricity from Barashini fiddler to Bongabari fiddler and other local issue. Immediately after receiving the information I along with force rushed to the spot after being instructed by I.C Purulia (M) PS with Govt. vehicle WB38J/2320 at about 09.15 hrs. As soon as I arrived at the spot, I found that the road has been blocked by the rabble of about 200 of Golkunda village, Mamurjore village with the help of Traffic guard rail, wooden log etc. After forming un-law full assembly under the leadership of (i) Bikash Paul S/O Lt. Misan Kr. Paul of Golkunda (ii) Sampad Chatterjee S/O Haradhan Chatterjee of do (iii) Gopal Mahato S/O Jogindra Mahato of do (iv) Anup Mukherjee S/O Asim Mukherjee of Mamurjore (v) Nilu Chatterjee S/O Alok Chatterjee of do all of PS-Purulia (M), Dist-Purulia. Subsequently I saw some of the villagers under the leadership of Bikash Paul threatened the drivers of the vehicle with dire consequences by lathi if they tried to move the vehicles. The vehicular traffic was totally disrupted and seized along the Purulia-Barakar road. I talked with the leaders to with draw the blocked but they paid no heed to my words and they demanded for the immediate fiddler change. Thereafter, I informed the matter to I.C Purulia (M) PS. Despite of all I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal. I along with force started to disperse them from the road but the road blockers obstructed us adamantly from the discharge of our public functions. Latter I.C Purulia (M) PS arrived at the spot and after the prolonged discussion the mob withdrew the blocked at 11.15 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the villagers of Golkunda village and Mamurjore village committed offence u/s 143/186/283/506 IPC & 18 W.B Highway act. 1964 under the leadership of supra noted persons ergo, I submitted suo moto complain before your good self to started specific case against them.
