That, all the above noted person without any reason abused me in filthy language and also assaulted me mercilessly and also driven me out from their house in mid night and also I was also compelled to sleep in the verandah. That they also even the

That they also blamed me as a barren lady for that they gave second marriage of my husband. Meanwhile my husband Thakurdas Mahali contact second marriage and is residing with the said second wife.

That since I was driven from my matrimonial house after one year of my marriage I am residing at my paternal house, but my husband or my in-laws never take any information of me nor they have taken any steps taken back in their house, though my brother and others relations are so many occasions visited my in-laws house but they refused.

That the matter was reported to our local police, but as the police very much reluctant to take legal action against those miscreants for that I compelled to file

this case against those miscreants under the law and oblige.
