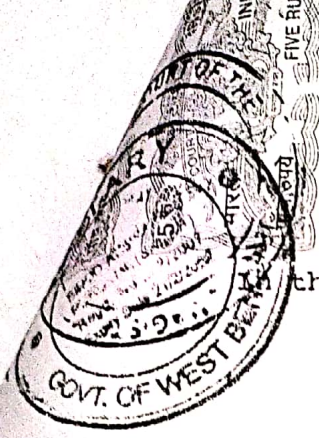

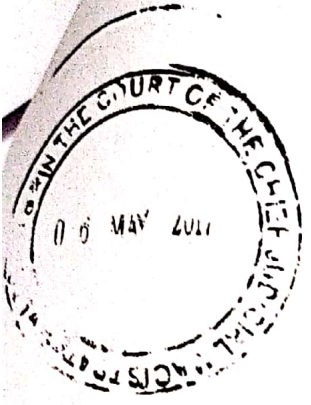

E. Offences:-

U/s 498-A, 323 I.P.C.

The above-named complainant begs to state as follows:-

- 1.---That the complainant is the legally married wife of the accused No.1 Santa Mandal. Their marriage were solemnised on 18-07-2015, after performing all religion rites and customs prevailing as their community and according to Hindu Law.
- 2.---That at the time of ~~wixx~~ marriage between the complainant and accused No.1, the father of the complt. gave Rs.1,20,000/- (one Lakh twenty thousand) in cash 50 grams Golden ornaments, Almirah, Show-case, Divan wrist watch and other utensils valued at Rs.50,000/- (fifty thousand) to the accused persons as per their demand as dowry.
- 3.---That after marriage of the complainant she had been to the house of the accused person at village Girrah, P.S. Chatna, Dist. Bankura and started her matrimonial home with lots of dreams and aspiration and the marriage was duly consumated.
- 4.---That after marriage the complainant and accused No.1 resided as husband and wife peacefully only for 3 months, There after accused No.1 to 5 began to make torture

both physically and mentally to complainant.

5.---That during the staying of the complainant the accused persons No. 1 to 5 told the complainant to bring Rs.20,000/-(Twenty thousand) from her father. The father of the complainant gave Rs.20,000/- (Twenty thousand) to the accused persons as per demand. Again the accused persons demanded Rs.20,000/- (Twenty thousand) and told the complainant to bring the same from her father. But the complainant and her father expressed their inability to meet the illegal demand of the accused No.1 to 5.

6.---That on 06-06-2016 the accused persons No.1 to 5 forcibly caught hold the complainant and sprayed Kerosin in the Sari and all over body of the complainant and attempt to set fire in the body but grace of God father and mother of the complainant entered in the house of the accused persons at that time and rescue the complainant from the hands of the accused and also grace of god any how complainant saved her life. The complt. as she is a good wife tolerated all the illtreatment some how and for that several times. The complainant went to her father's house and reported the matter. The father of the complainant came to the house of the accused persons and told the accused persons to keep the complainant peacefully but they did not hear their good counselling but they became very angry and rebuked him in filthy language and the accused No. 1 to 5 told loudly to the father of the complainant that

another Rs.20,000/- as dowry to them, otherwise they kill her.

7.---That on 10-08-2016 the accused No.1 to 5 assaulted the complainant with fists and blows and denying to given any food even. The accused No.1 to 5 many occasion tried to finish the life of the complainant by strangulation but the grace of god, the complainant saved her life. One day accused No.1 used to came to his house in drunken condition and assaulted the complainant in presence of his father and mother-~~to-law~~.

5.---That on 26-02-2017 the accused persons No.1 to 5 assaulted the complainant by lathi in her back mercilessly and snatching all the ornaments from the complainant and drove the complainant from her matrimonial home and since then the complainant has been staying her father's house with utmost difficulties.

9.---That the accused persons No.1 to 5 still threatening to kill the complainant and her father, mother by different ways. That due to constant threatening, torture, illtreatment and harassment of the accused persons No.1 to 5 the complainant and her father, mother became sicking nervous and failed on insecure.

10.---That the incident was reported to the local police of Purulia (M) P.S. and also to the S.P. Purulia. But the police Purulia (M) P.S. are quite mum and has not started any police case against the present accused persons. So the complainant is bound to filed the instant petition for proper relief.

In the circumstances, it is therefore prayed that your honour will kind enough to send this complaint to Purulia (M) P.S. and directed them to investigate the case treating this petition as F.I.R./s 156(3) Cr.P.C.
