

1. That the complainant and the accused persons are residents of village Sitalpur under p.s. Purulia(M) and within the jurisdiction of this Ld. Court.
2. That the complainant is the rightful owner and possessor of the R.S. plot no. 1843 area 7 decimals of mouza Sitalpur p.s. Purulia(M) and during L.R. operation on the aforesaid plot has been recorded in the name of the ^{father of} complainant. The complainant has got every right, title interest and possession over the aforesaid plot. The complainant has planted so many trees like Karam, Arjun, Neem etc over the his said land and the said trees are big ~~now~~ one.
3. That on the date of occurrence i.e., on 24.4.2017 at about 10 A.M. the accused persons namely Dasarath Mahato and Bulet Mahato being armed with Lathi and Kural in their hands forcibly and illegally entered in ^{to} the land i.e., R.S. plot no. 1843 area 7 decimals and they began to cut and remove the branches of Karam tree of the complainant with the help of Kural. The accused persons were cut and remove 4 nos of branches of the one Karam tree of the complainant. The complainant raised objection against the said illegal activities of the accused persons, but the accused persons threatened to the complainant in a dire consequences and they threatened ^{to the complainant} by saying that if any body came to the spot then they will kill him. The complainant sustained loss of Rs. 2000/- The witnesses named

above saw the incident and the matter was also reported to them. The said stolen articles are still now kept in the home of the accused persons.

4. That there after the complainant informed the matter to the O/C Purulia(M) against the accused persons stating the aforesaid facts but O/C Purulia (M) did not take any action against the accused person till today Accordingly the complainant reported the matter to the S.P. Purulia on 26.4. 2017 but till not police did not take any steps against the accused persons. The accused persons still now threatening to the complainant in a dire consequence. so the complainant has been compelled to file this case before your Honour Court.

5. That the complainant is poor man and he has got no capacity to prosecute the case in his personal capacity and there is question of search and seizure, so police case is required for the ends of justice.
