Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No. WB55A/3311 loaded with sand. The fact of the case in brief is that on 18/01/2017 morning I along with force were on day mobile duty on Purulia-Ranchi road. During mobile duty on 18/01/2017 at about 11.25 hrs received a credible source information that the above noted (Tractor) is coming from Telidi Ghat towards Sonajuri village side loaded with sand. After receiving this information we were proceeding towards Sonajuri village morh under Purulia(M) P.S. When we reached near Sonajuri village morh under Purulia(M) P.S, found that the above noted (Tractor) was coming from Telidi Ghat. On seeing the Police party the driver of the said tractor stopped the tractor in a distance from Sonajuri village morh. We rushed to the tractor and the driver then fled away after keeping the tractor near Sonajuri village morh at 12:05 hrs. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the tractor bearing registration No WB55A/3311 loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Purulia (M) P.S. As such the driver and owner of the tractor who are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) bearing registration No WB55A/3311 may kindly be started and arrange for its investigation.
