Sir,

In producing herewith one arrested accd. person namely Jiten Roy (45 yrs) s/o Lt. Kali Roy of Vill- Ramdi, PS- Purulia (M), District - Purulia with seized articles 40 Bottels of Country Spirit styled as DILKHUS, each Bottle contains 600 ml which were seized under proper seizure list.

I beg to submit that on today i.e. (17.05.17) during special raid duty acting of a secret source information at 14:25 hrs I along with force conducted raid house of the Jiten Roy (45 yrs) s/o Lt. Kali Roy of Vill- Ramdi, PS- Purulia (M), District - Purulia and found that the above noted accused person is keeping and selling ID liquor which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of ID liquor from his house. As such I seized 40 Bottels of Country Spirit styled as DILKHUS each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses.

The above noted arrested accd. person namely Jiten Roy (45 yrs) s/o Lt. Kali Roy of Vill- Ramdi, PS- Purulia (M), District - Purulia committed offence u/s 46 A ( c ) B.E.Act. 1909 for unauthorized possession and sale of ID liquor and country spirit from his house.

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Jiten Roy (45 yrs) s/o Lt. Kali Roy of Vill- Ramdi, PS- Purulia (M), District - Purulia and arrange for its investigation.
