Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No. WB 55/2884 attached with Trolley loaded with sand. The fact of the case in brief is that on 18.05.17 at 11:15 hrs while myself along with force were performing mobile duty received a source information I along with force were proceeding towards Kotlui Nadi Ghat under this PS. When we reached near Kotlui Ghat at about 11:55 hrs found that the above noted (Tractor) was coming from Nadi Ghat towards Purulia Town on the Morum road. On seeing the Police party the driver of the said tractor stopped the tractor in a distance from Raibandh More the driver fled away after keeping the tractor near the Raibandh More. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the sand but none turned up and demanded that he is the actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing registration No WB 55/2884 loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Purulia (M) P.S. So it reason to belief that they procured the said sand from Kansaboti river at Kotlui Nadi Ghat by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Reg. No WB 55/2884.
