I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Biplab Bouri(Pintu) S/O Ramchandra Bouri of Vill - Charrah, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 18.05.2017 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr. SAE(E), & Sri Akshay Pr. Bit, O.E. of Telkalpara CCC, WBSEDCL conducted a raid programme at village Charrah under Purulia(M) P.S. When our team at about 11.00 A.M. entered to the Domestic premises of Biplab Bouri, we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by way of tampering terminal seal of meter and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.30 A.M.after completion of inspection & necessary formalities.
