In producing herewith the accused persons namely (1) MDSamimuddin (52) s/o Late MD Mainuddin of Garhjoypur, PS Joypur, Dist Purulia & (2) MD Asif (40) S/O Late MD Rahim Bakash, of Tata Jugsalai, P.S-Jugsalai, Dist. Jamshedpur, Jharkhand under arrest and seized articles (i) One Halka golapi coloured plastic bag with 21kg 700 grams Cannabis/Ganja 2) 03 brown colour envelope containing 100 gm each of loose Cannabis/Ganja Which have been collected from bag as sample & 3) One Discover black colour Motor Cycle without number plate bearing Chasis No. MD2DSJZZTPE 16646 and Engine No. JZUBPE22167 under proper seizure list sealed and level duly signed by the witnesses and accused persons, I SI Sadhan Kr. Banerjee, O/C Purulia (M) PS do hereby lodge this complaint suo-motu against the above noted 02 (two) accused persons for committing an offence punishable U/S 20 (b)(i)/29 NDPS Act 1985. Today (18.05.17) at 13.05 hrs. received a reliable source information that 02 (two) drug peddler namely (1) MD. Samimuddin s/o Late MD Mainuddin of Garhjoypur, PS Joypur, Dist Purulia & (2) MD Asif S/O Late MD Rahim Bakash, of Tata Jugsalai, P.S-Jugsalai, Dist. Jamshedpur, Jharkhand were going towards Tata from Purulia side. The source also informed that they were carrying one plastic bag containing Cannabis/Ganja on middle of rider and pillion rider of motorcycle. I noted the fact in G.D. vide Purulia (M) PS GDE No 884 dtd 18.05.17, informed the matter to CI Sadar, Purulia & Dy. SP (H.Q), Purulia, and other Superiors Officers of Purulia District. As per their direction myself along with my source, SI Gopal Man, C/665 Robindra Nath Gorai, C/1051 Satyajit Acharyya, C/1454 Ashok Kr. Mahato HG/1574 Swapan Mahato vide C.C. No. 2252/17 dtd 18. 05.17 left for Karamara side area to work out the information by Govt. vehicle having Reg. No. W.B 56B/5363 also carried seal, gala, match box, candle, brown paper, weighing instrument.

Today i.e, 18.05.17 at 13:45 hrs reached near Jadav Hotel, Karamara within a visible distance of place of assembly of suspect & got down from the vehicle, kept the vehicle in a hiding place, we ambushed ourselves at different places with proper briefing. Kept watch at the pacca road approaching to the Jadav Hotel, Karamara beside Purulia-Tata Road(NH-34). At about 14.05 hrs one motorcycle rider, identified as MD Asif with pillion rider MD Samimuddin duly identified by source with Discover Black colour motorcycle without number plate arrived at the pacca road just in-front of the Jadav Hotel. We watched them for a considerable period, meanwhile,

I along with accompanied officers & force disclosing our identities surrounded them & also detained them with the said bag. On being asked they disclosed their identity as 1) MDSamimuddin (52) s/o Late MD Mainuddin of Garh Joypur, PS Joypur, Dist Purulia & (2) MD Asif (40) S/O Late MD Rahim Bakash, Tata Jugsalai, P.S-Jugsalai, Dist. Jamshedpur, Jharkhand. On interrogation they confessed that the said bag contained Cannabis/Ganja which was tight by a rope. They also stated that they carrying the same for selling at Tata side. Informed the matter to CI, Sadar, Purulia and Dy. SP (H.Q) Purulia. Accordingly informed BDO Purulia-I. Thereafter, on arrival at 14:45 hrs of BDO Purulia-I and C.I Sadar Circle disclosed their identity and explained their reason for arriving there. I issued notice to both accused persons asking them whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, both detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate. After a while two public witnesses namely 1) Ajoy Chouhan S/O Ram ugra Chouhan of Kapoor bagan, P.S Purulia(T), Dist. Purulia, owner of Bishal Line Hotel, Karamara under Purulia(M) P.S, Dist. Purulia &(2) Radheshyam Gope S/O Manjura Gope of Amchuria, P.S Purulia(M), Dist. Purulia, owner of Jadav Hotel, Karamara, P.S- Purulia(M) became ready to assist us in conducting search & seizure. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Dibya Jyoti Das, B.D.O Purulia-I and detained persons. At first myself with the help of officers and force

searched MD.Samimuddin and then MD Asif and their belonging at the spot. During search of them found one halka golapi coloured plastic bag contained 22 kg. Ganja . Accordingly I seized the said bag under proper seizure list after taken as sample in 03(three) brown colour envelope containing 100 grams each duly signed by the public witnesses, police witnesses and accused persons in presence of BDO Purulia-I. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused persons. I also seized one Discover Black colour motorcycle without number plate bearing Chasis No. MD2DSJZZZTPE 16646 and Engine No. JZUBPE22167 from the possession of rider Md. Asif. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrested them. Informed them ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and leveling were done between 15:05 hrs and 17:15 hrs under direct supervision of BDO Purulia-I and CI Sadar, Purulia.

So I started Purulia (M) P.S. Case No.135 /17 Dt. 18.05.17 U/S 20(b)(i)/29 NDPS Act 1985 as Suo-motu against the accused persons namely (1) MDSamimuddin (52) s/o MD Mainuddin of Garhjoypur, PS Joypur, Dist Purulia & (2) MD Asif (40) S/O MD Rahim Bakash, of Tata Jugsalai, P.S-Jugsalai, Dist. Jamshedpur, Jharkhand and directed SI Anup Ghosh, I/C Tamna O.P under Purulia(M) P.S for its investigation.
