I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Sri Nityananda Mahato S/O Lt. Rabilochan Mahato of Vill-Bhagabandh, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 01.02.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE (E) S/O Sri Pradip Kumar Maity, Sri Jogeswar Mahato (L.M.), S/O-Lt. Nutan Mahato of Telkalpara CCC, WBSEDCL, conducted a raid programme. at village Bhagabandh under Purulia(M) P.S. When our team at about 02.00 P.M entered to the Domestic premises of Nityananda Mahato. we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run water pump for domestic purpose, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, at first disconnected the wire with hooking arrangement from LTOH line and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.30 P.M after completion of inspection & necessary formalities.

Sri Nityananda Mahato S/O Lt. Rabilochan Mahato of Vill-Bhagabandh, PS-Purulia (M) has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
