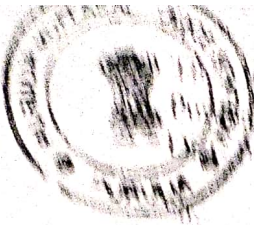

In producing here with the arrested accused persons namely (i) Dipak Bauri (25 yrs) S/o Sunil Bauri of Vill-PC+PS- Nituria, Dist- Purulia, (ii) Amar Bauri (40 yrs) S/o Lt. Anil Bauri of Vill- Khuthibari, PC+PS- Nituria, Dist- Purulia and one seized vehicle (Truck) bearing registration No. CG/04JB-3713 loaded with approx 20 (twenty) ton steam coal. Part of the case in brief is that on 07/08/17 myself along with force were on night patrol duty on Purulia Barakar Road. During raid duty received credible source information that the above named (Truck) is coming from Baghmachhapur village North. When we reached at Purulia Village North, found that the above named (Truck) was coming from Baghmachhapur side. We stopped the said truck at Purulia North in Purulia Bazar park road at 07:30 hrs and searched the said (Truck) found that the said (Truck) is loaded with approx 20 (twenty) ton steam coal. On asked the driver disclosed his identity as Dipak Bauri (25 yrs) S/o Sunil Bauri of Vill-PC+PS- Nituria, Dist- Purulia and there was another person with the vehicle (Truck) who disclosed his identity as Amar Bauri (40 yrs) S/o Lt. Anil Bauri of Vill- Khuthibari, PC+PS- Nituria, Dist- Purulia. I asked the driver Dipak Mahanta to produce the valid documents in respect of said steam coal as well as papers in respect of the said vehicle (Truck). But he failed to produce any valid documents in respect of the said coal and vehicle (Truck). On asked he stated that the said coal is loaded from Barakar North. The driver and Amar Bauri confessed his guilt implicating themselves owner of the vehicle (Truck) bearing registration No CG/04JB-3713 who are directly involved in this case. The driver also stated that they all are running clandestine business since long through this coal for wrongful gain. As such there is every reason to believe that the driver, Dipak Bauri, Amar Bauri and owner of the vehicle bearing registration No CG/04JB-3713 with ill motive are transporting steam coal illegally. So they are liable for offence punishable U/S 379/411/414 IPC. As such I seized the truck bearing registration No CG/04JB-3713 loaded with approx 20 (twenty) ton steam coal under proper seizure list in presence of my accompanied staff and also arrested the accused driver (i) Dipak Bauri (25 yrs) S/o Sunil Bauri of Vill-PC+PS- Nituria, Dist- Purulia & (ii) Amar Bauri (40 yrs) S/o Lt. Anil Bauri of Vill- Khuthibari, PC+PS- Nituria, Dist- Purulia.

Therefore I pray before you that a case against accused persons namely(i) Dipak Bauri (25 yrs) S/o Sunil Bauri of Vill-PC+PS- Nituria, Dist- Purulia, driver of vehicle bearing registration No CG/04JB-3713, 2. Amar Bauri (40 yrs) S/o Lt. Anil Bauri of Vill- Khuthibari, PC+PS- Nituria, Dist- Purulia. & 3. Owner of the truck bearing registration No CG/04JB-3713 may kindly be started and arrange for its investigation.
