I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Mukshad Ansary S/O Lt.Abdul Ansary of Vill-Golkunda, P.O.-Mamurjore, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Yesterday, i.e. on 08.02.2017 I, Prashant Kishor, AE(E), along with Sri Chinmoy Maity,SAE(E) S/O-Pradip Kumar Maity & Sri Sasti Karmakar, Sr.L.M., S/O Lt. Makhan Karmakar of Telkalpara CCC of WBSEDCL conducted a raid programme at about 04.30 P.M. to 05.00 P.M. at Golkunda village under Purulia(M) P.S. When our team entered to the commercial premises of Mukshad Ansary, we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by way of tampering service cable and run commercial appliances, so, original consumption was not recorded by meter, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses the meter with bypassing arrangement dismantled and seized and seizure list prepare . The signature of the accused and local witnesses could not able to obtain due to refusal. The seized material labelled in presence of the local witnesses.

Mukshad Ansary S/O Lt. Abdul Ansary of Vill-Golkunda, P.O.-Mamurjore, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
